

## Terms and Conditions

1. Depositor accepts this receipt as correct in all respect, unless notice by registered mail within five days after date hereof is given Pittsburgh Fur Storage LLC. of any error or irregularity herein, and as superseding any temporary or interim receipt heretofore given.
2. At the request of the depositor and as part of the consideration for the charges set opposite each item herein listed below, the undersigned hereby agrees to effect for the benefit of the depositor insurance on the articles listed in this receipt which shall, in terms usual to such insurance, cover against loss by fire and theft for the value of \$100 (one hundred dollars) each item, which value shall represent respectively the limit of liability for loss of or damage to the same.
3. Each and every statement contained in this receipt and all provisions thereof shall for purposes of obtaining the benefit of insurance constitute an application by the depositor thereof and the terms and conditions of the receipt are apart of the contract of insurance, its provisions insuring to the benefit of the insurance company to the same extent that they insure to the benefit of the undersigned, but the terms of this receipt shall not extend in kind or amount the insurance provided by the policy.
4. The delivery of the articles or garments or any of them to any person presenting this receipt (in the absence at the time of such presentation of any written notice to the undersigned from the depositor of the loss of said receipt) shall be deemed delivery to the depositor or the depositor's agent and no obligation or liability is assumed for any error or loss resulting there from directly or indirectly. The delivery of articles or any of them to a common carrier, or at any address as directed by the depositor or depositor's agent or to the depositor's address as given herein shall be deemed delivery to the depositor and no obligation or liability is assumed for any error or loss resulting therefrom directly or indirectly.
5. No one is authorized on behalf of Pittsburgh Fur Storage LLC to modify or alter the above agreement in any respect as above provided.
6. This agreement is not assignable and not negotiable.
7. It is specifically understood and agreed that if payment of storage charges shall not have been made and the article or articles listed herein withdrawn within three years, PITTSBURGH FUR STORAGE LLC, shall be, and by this contract is fully empowered to sell said article or articles at public or private sale without advertisement thereof and mail to the DEPOSITOR'S address given hereon said notice being deemed to have been given when the letter shall have been delivered to the proper branch of the Post Office Department properly stamped for mailing. The amount received at such sale shall be deemed to be the fair value of said article at the same time of sale, and PITTSBURGH FUR STORAGE LCC is relieved of any liability by reason of the sale of said article or articles.
